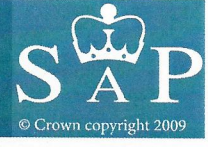

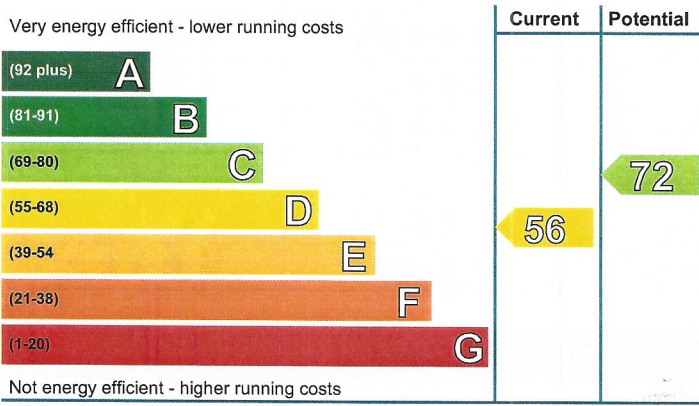

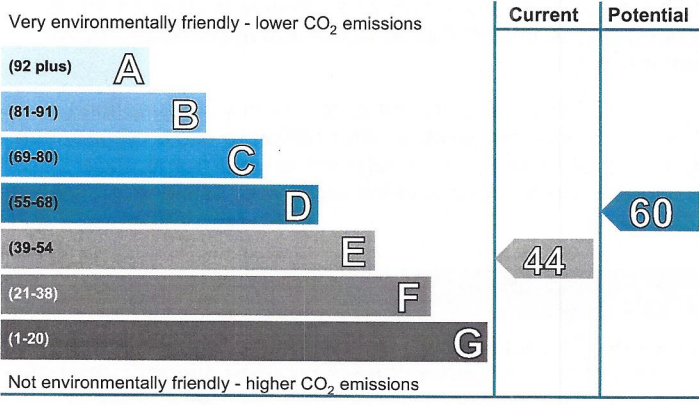


Energy Efficiency Rating
